Notification of 2026 non-Dealing Days

1) What’s happening?

We would like to inform you about a number of **non-Dealing Days** in 2026 that apply to your Fund.

Non-Dealing Days are days on which any subscription, redemption and/or switch request you make will **not** be processed by the Company and will instead be deferred to the next Dealing Day.

In addition, we will not calculate the Net Asset Value or publish the Share price of an impacted Fund on a non-Dealing Day.

Finally, non-Dealing Days are also non-Business Days from a settlement perspective. If you are selling your Shares, we would normally return proceeds to you within three Business Days. If you are buying Shares, we normally need to receive your money or funds within three Business Days (or two Business Days in respect of the FSSA China A Shares Fund). Given non-Dealing Days are also non-Business Days, this will impact when your proceeds are received if you are redeeming your Shares, or when we need to receive money or funds from you, if you are buying Shares.

2) When are these non-Dealing Days in 2026?

Our non-Dealing Days are set out in the Appendix to this letter as follows:
